The allocated funds were used to support key personnel, including program facilitators, site coordinators, and youth program managers, ensuring effective program delivery. Employee benefits and payroll taxes were covered to maintain staff well-being and compliance with employment regulations. Additionally, funds supported administrative leadership roles essential for program oversight.

Program expenses included STEM supplies, food and snacks for participants, and general materials needed for daily operations. Contracted enrichment services provided specialized programming, while travel funds covered staff transportation and college tour expenses. Insurance, including auto and general liability coverage, was secured to protect program activities, along with a fidelity bond for financial security.

Technology and community engagement efforts were also funded, including the Bright wheel sign-in system for participant tracking and resources for parent and holiday events.
